 Premium Sedan category includes Ciaz, Honda city or similar; Sedan category includes Dzire, Amaze or similar; SUV / MUV category includes 6 Seaters or above like Ertiga, Innova or similar. The cars given are indicative in nature.

- No separate night charges are payable and the same should be covered by the Rate for Extra hour to be quoted in Table 2.
- The Toll charges, Parking fee or entry Taxes payable locally or outstation shall be reimbursed by the Buyer.

Terms and Conditions

- The vendor should have all the categories of vehicles mentioned, and should submit the proofs thereof such as Registration certificate.
- The vehicles supplied should have necessary permit to ply on the roads of the state of Goa.
- The vehicles should preferably be new and in excellent running condition. In case of breakdown the vehicle service supplier should immediately provide replacement vehicle.
- Service provider shall ensure that assigned vehicle and driver report as per schedule provided by user with full or sufficient tank of fuel. Service provider shall ensure that all maintenance works related to assigned vehicle shall be carried out during off-duty hours.
- Regular and daily sanitization of the vehicle should be done, in line with COVID-19 protocols. The drivers deployed should also observe COVID-19 protocols such as wearing of masks, physical distancing and cleaning and washing of hands.
- All vehicles should be equipped with an emergency medical kit.
- In view of the exigency of work, the drivers should be willing to work long hours. The duty hours will start from the reporting point and also service will end at the drop point.
- The tender is liable to be cancelled anytime, without citing any reason
- Any disputes that may arise shall be arbitrated as per the Indian Arbitration Act.

Tender Evaluation

The number of vehicles mentioned in Table 1 above is for the purpose of calculation.

The successful bidder should be in a position to supply (up to 7-8) additional vehicles than the approximate daily requirement, during the period of peak demand, which will be notified in advance.

The package shall be calculated on a notional basis per day by multiplying rates quoted for 10 hours/80 km with the number of vehicles for each category, and adding these to find the total rate considering all three categories, as given in the following table.
