#### Introduction

National Agriculture Market is a pan-India electronic trading (e-trading) portal that seeks to network the existing physical APMCs through a virtual platform to create a unified national market for agricultural commodities. e-NAM is a "virtual" market, but it has a physical market (mandi) at the back end.

The Portal provides a single window service for all APMC-related information and services. This includes commodity arrivals, quality & prices, buy & sell offers, provision to respond to trade offers, and electronic payment settlement directly into farmers' accounts, among other services. While material flow (agricultural produce) shall continue through mandis, the online marketing portal will reduce transaction costs, bridge information asymmetry, and help expand market access for farmers.

Stakeholders registered on the **e-NAM Platform** as of April 30th, 2023: A total of 1,79,40,992 stakeholders have been registered. It includes <u>2822 FPOs</u> that have been registered on the e-NAM platform.



## Progress and Achievements of e-NAM Modules launched

e-NAM Platform of **Platforms** -Platform of Platforms (PoP) is a new framework developed under the e-NAM ecosystem which aims to integrate various Service Provider Platform like Trading, Assaying, Transportation, Warehousing, Fintech, Market Information, Sorting and Grading, Agri Input & Advisory Services, which will enable Farmers. FPO. Traders. and other stakeholders to access larger




market ecosystem through a single window.


- **IMD Weather Forecast for Mandis** Integration of Weather forecast information from the Indian Meteorological Department (IMD) with e-NAM, providing minimum and maximum temperatures along with "current day" forecast for e-NAM mandis and nearby areas.
- **Real-Time Price Dissemination System -** 'Market Information Page' designed as a single source of information providing farmers with the current price of the commodities being traded in e-NAM mandis of the respective states.
- **Cooperative Module** Cooperative Trading module facilitates Cooperatives to register on e-NAM and to trade their produce directly from their collection center/warehouses without bringing the produce to the APMCs.
- **e-NAM Directory** A directory with compiled information on e-NAM processes and respective mandi information.

The budget provision for the Ministry of Agriculture and Farmers Welfare in the year 2023-2024 stands at Rs. 125,035.79 crore, showcasing a substantial increase of over 7 times compared to the <u>budget provision of Rs.</u> 27,049 crore allocated in the year 2013-2014.

The noteworthy growth in budget allocation reflects the government's heightened focus and commitment to bolstering the agriculture sector and supporting the welfare of farmers in the country.



# Progress in Rajasthan



- As on July 26, 2023, the total number of Stakeholders registered on e-Nam from Rajasthan: 16,15,913.
- Total number of Mandis registered: 145
- Total no. of Traders/ Commission Agents: 1,10,598
- Total no. of farmers registered: **15,05,053**
- Total no. of FPOs: 262
- The total sum of funds released by the Central government for e-NAM to Rajasthan from 2015-2023 is **Rs 92.82 crore** (as on 28.02.2023)
