In the relevant file of the concerned Section/Unit involving financial approvals, it shall invariably be mentioned that ***"The proposed expenditure is Recurring or Non-recurring and it is within the powers of Pr. DG (M&C) or within the powers of DG (Admn.)/ ADG (Admn.) etc., as the case may be"***.

3. The financial and administrative powers vested in Ministry of I & B, which have been delegated to Pr. DG (M&C) vide Ministry of I & B's Order No. 25/26/2006-Press, dated 11.02.2008 will continue to be exercised by Pr. DG (M&C).
