**Subject: Amendment to 'Procedure for inclusion/ updating Wind Turbine Model in the Revised List of Models and Manufacturers of Wind Turbines (RLMM)' - Reg.**

The undersigned is directed to convey the following amendments to 'Procedure to apply for inclusion of a Wind Turbine Model in the Revised List of Models and Manufacturers of Wind Turbines (RLMM)' issued by this Ministry vide OM No. 293/8/2017-Wind dated 01.11.2018:

From the date of issue of this OM, RLMM will be renamed as Approved List of Models and Manufacturers (Wind) i.e. ALMM(Wind).

4 (h)	<p>The Application along with all required documents should be submitted to:</p> <p>Dr. Rahul Rawat Scientist 'B' Grid Interactive Wind Power Division Ministry of New and Renewable Energy Block No. 14, CGO Complex, Lodi Road, New Delhi- 110003 Email- rahul.mnre@gov.in, phone no- 011-24363402</p>	<p>The Type Certificate of the wind turbine model shall mandatorily include Blade, Tower, Gearbox, Generator and Special Bearings (Main, Pitch and Yaw Bearing) assembly/manufacturing facility.</p> <p>A Technical Team constituted by MNRE shall inspect the manufacturing facilities for Blade, Tower, Gear Box, Generator and Special Bearings.</p> <p>A separate List named as Approved List of Models and Manufacturers (Wind Turbine Components) i.e ALMM (Wind Turbine Components) will be issued after inspection of such facilities.</p> <p>A separate Standard Operating procedure (SOP) for this inspection will be issued.</p> <p>These components shall only be sourced from such facilities which are included in ALMM-(Wind Turbine Component).</p>
4 (i)	Nil	<p>In order to strengthen the cybersecurity ecosystem, the followings shall be ensured;</p> <ol style="list-style-type: none"> <li>Mandatorily locating Data Centre and/or servers in India. All data pertaining to wind turbine must be stored and maintained within India.</li> <li>Transferring real-time operational data outside India shall be prohibited. Operational control of wind turbine must be conducted exclusively from a facility located within India.</li> <li>Mandatorily locating R&amp;D Centre in India within one year from issuance of this OM</li> </ol>

2. **Exemption Clause:** The following cases will be exempted from clause 4 (h) of this OM:

- a. The already bidded projects (projects where bids have been closed before issuance of this OM), subject to commissioning of the project within three years of issue of this OM.
- b. The wind power projects to be commissioned within Eighteen Months (from the date of issuance of this OM) under Captive/Open Access/C&I/Third Party sale mode.
- c. (i) New Wind Turbine Manufacturer and / or New Model, as per SOP, limited to 800 MW for a period of two years from the date of enlistment in ALMM(Wind).  
(ii) A component sourcing portal shall be developed for monitoring the manufacturing & supply of wind turbines and all the listed wind turbine manufacturers are necessarily have to register and submit data through this portal.  
(iii) New Wind Turbine Models/Manufacturers enlisted under this exemption are required to submit quarterly progress report indicating achievement of requirement mentioned in clause 4(h) of this OM. Failure of submission of Quarterly Progress Report may lead to delisting of that particular model.

3. This amendment shall be applicable on all wind turbine models including existing models enlisted in RLMM and new wind turbine models to be submitted for enlistment.

4. Any import required for manufacturing of wind turbines needs to be in compliance with the provisions of Renewable Energy Equipment Import Monitoring System (REEIMS) as and when it gets notified.

5. All other conditions/procedures applicable for the inclusion of wind turbine in ALMM (Wind) remain unchanged.

6. This is issued with the approval of competent authority.
