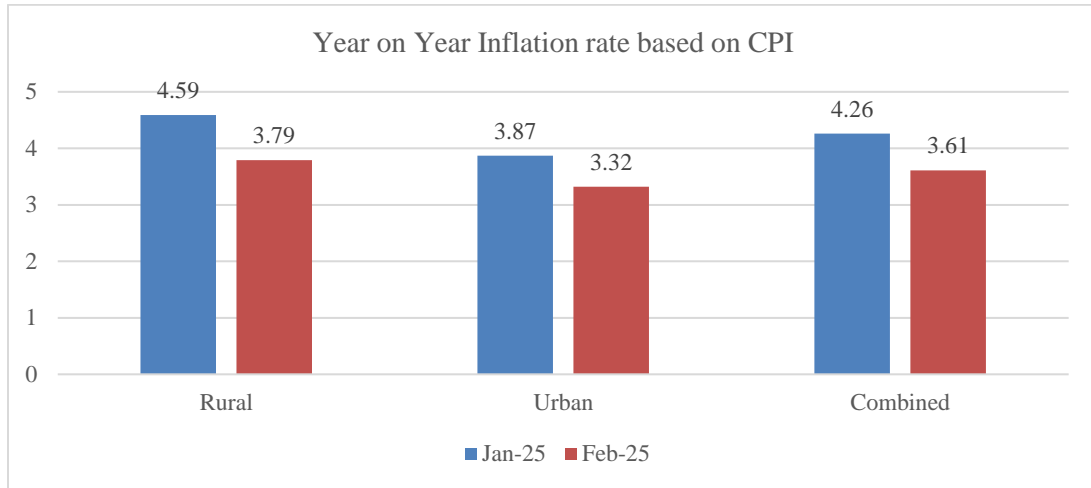

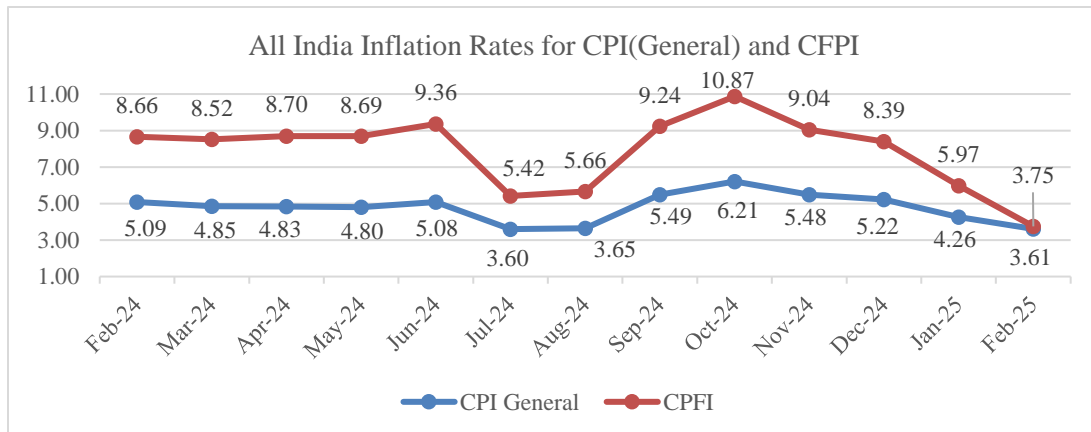
**CONSUMER PRICE INDEX NUMBERS ON BASE 2012=100 FOR RURAL,
URBAN AND COMBINED FOR THE MONTH OF FEBRUARY 2025**

I. Key highlights:

1. Year-on-year inflation rate based on All India Consumer Price Index (CPI) for the month of February, 2025 over February, 2024 is 3.61% (Provisional). There is decline of 65 basis points in headline inflation of February, 2025 in comparison to January, 2025. It is the lowest year-on-year inflation after July, 2024.



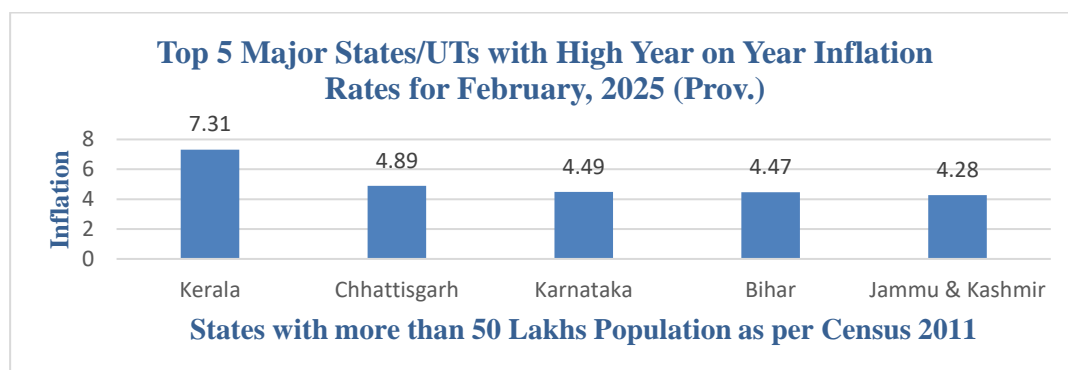
2. **Food Inflation:** Year-on-year inflation rate based on All India Consumer Food Price Index (CFPI) for the month of February, 2025 over February, 2024 is 3.75% (Provisional). Corresponding inflation rate for rural and urban are 4.06% and 3.20%, respectively. All India inflation rates for CPI (General) and CFPI over the last 13 months are shown below. A sharp decline of 222 basis point is observed in food inflation in February, 2025 in comparison to January, 2025. The food inflation in February, 2025 is the lowest after May, 2023.



3. **Rural Inflation:** Sharp decline in headline and food inflation in rural sector observed in February,

2025. The headline inflation is 3.79% (provisional) in February, 2025 while the same was 4.59% in January, 2025. The CFPI based food inflation in rural sector is observed as 4.06% in February, 2025 in comparison to 6.31% in January, 2025.

4. **Urban Inflation:** Significant decline from 3.87% in January, 2025 to 3.32% (Provisional) in February, 2025 is observed in headline inflation of urban sector. Similar decline is observed in food inflation which is decreased from 5.53% in January, 2025 to 3.20% in February, 2025.
5. **Housing Inflation:** Year-on-year Housing inflation rate for the month of February, 2025 is 2.91%. Corresponding inflation rate for the month of January, 2025 was 2.82%. The housing index is compiled for urban sector only.
6. **Fuel & light:** Year-on-year Fuel & light inflation rate for the month of February, 2025 is -1.33 %. Corresponding inflation rate for the month of January, 2025 was -1.49 %. It is combined inflation rate for both rural and urban sector.
7. **Education Inflation:** Year-on-year Education inflation rate for the month of February, 2025 is 3.83%. The same education inflation was observed in the month of January, 2025. It is combined education inflation for both rural and urban sector.
8. **Health Inflation:** Year-on-year Health inflation rate for the month of February, 2025 is 4.12%. Corresponding inflation rate for the month of January, 2025 was 3.97%. It is combined health inflation for both rural and urban sector.
9. **Transport & Communication:** Year-on-year Transport & communication inflation rate for the month of February, 2025 is 2.87%. Corresponding inflation rate for the month of January, 2025 was 2.76%. It is combined inflation rate for both rural and urban sector.
10. The significant decline in headline inflation and food inflation during the month of February, 2025 is mainly attributed to decline in inflation of Vegetables, Egg, Meat & fish, Pulses & products and Milk & Products.
11. **Top five items with highest inflation:** The top five items showing highest year on year Inflation at All India level in February 2025 are coconut oil (54.48%), coconut (41.61%), gold (35.56%), silver (30.89%) and onion (30.42%)
12. **Top five items with lowest inflation:** The key items having lowest year on year inflation in February, 2025 are ginger (-35.81%), jeera (-28.77%), tomato (-28.51%), cauliflower (-21.19%), garlic (-20.32%). - IV. **Response rate:** The price data are collected from selected 1114 urban Markets and 1181 villages covering all States/UTs through personal visits by field staff of Field Operations Division of NSO, MoSPI on a weekly roster. During the month of February, 2025, NSO collected prices from 100% villages and 98.6% urban markets while the market-wise prices reported therein were 89.8% for rural and 92.6% for urban.
