Press Release

Release of Sub-Sectoral Trial Index of Services Production (ISP) for June 2026
(Base Year 2024–25)

- 8 out of the 19 sub-sectors recorded double-digit growth in June, 2026 as compared to June, 2025.
- 18 out of the 19 sub-sectors recorded positive growth in June, 2026.
- Top sub-sectors reporting strong growth in June, 2026 were Real Estate (24.7%), Retail Trade (18.0%), Wholesale Trade (15.1%), Administrative and Support Services (14.4%), IT and Computer Related Services (13.5%).

The Ministry of Statistics & Programme Implementation (MoSPI) releases the Index of Services Production (ISP) for the month of June 2026 in respect of 19 sub-sectors, with base year 2024–25. Sub – Sector wise trends in ISPs in June, 2026 over June, 2025 are given below:
