## CIRCULAR

### **Subject: Advisory for pilgrims booking through HGOs/PTOs for Haj 2026 - regarding.**

Reference is invited to this Department's earlier Notice No.Haj-15/4/2025-Haj-MoMA (C-147347) dated 04.12.2025 on the above subject, wherein all provisionally selected pilgrims were advised to complete the prescribed codal formalities for Haj 2026, including booking-related requirements, by **15.01.2026** and to comply with the deadline prescribed by the Kingdom of Saudi Arabia and to avoid last minute inconveniences.

2. Subsequently, representations have been received from pilgrims and other stakeholders seeking additional time to complete the aforesaid formalities. The matter has been examined by the competent authority in the Ministry.

3. In view of the requests received from the public and keeping in mind the larger interest of pilgrims, it has been decided to grant a final extension of time up to **25.01.2026** for completion of all remaining codal formalities. During this extended period, pilgrims are required to:

- complete the booking process;
- submit their valid passports to the HCoI or concerned Haj Group Organisers (HGOs); and
- ensure successful onboarding on the Nusuk Portal within the stipulated timeline.

4. Accordingly all pilgrims are advised to verify the registration status, quota and approval of the concerned HGO/PTO before booking and only book through authorised HGOs. It is once again reiterated that all concerned are required to strictly adhere to the revised timeline, as **no further extension beyond 25.01.2026 shall be granted under any circumstance.**

5. This issues with the approval of the Competent Authority.
