As per section 4(4) of the NMC Act, 2019, 10 members from amongst the nominees of the States/UTs and 9 members from amongst the nominees of the State Medical Councils in the Medical Advisory Council are to be appointed as part-time members in the National Medical Commission on rotation basis for a period of two years.

As per section 17(5) of the NMC Act, 2019, one member in each Autonomous Board is to be appointed from the elected members of the SMC in the Medical Advisory Council.

For constitution of the Search Committee, one expert is to be nominated from amongst the nine part-time Members of the State Medical Councils in the Commission under section 5(1)(c) of the NMC Act, 2019.

The rules with regard to appointment of part-time member in the National Medical Commission, four members in the autonomous boards and one expert in the Search Committee prescribe that the part-time Members of the Commission to be appointed under clauses (b) and (c) of sub-section (4) of section 4, one expert in Search Committee under section 5(1)(c) of the NMC Act, 2019 and fourth member in the Autonomous Boards under section 17(5) shall be selected by draw of lots from the nominees of States/UTs/SMCs in the Medical Advisory Council.
