All-India provisional General (all-groups), Group and Sub-group level CPI and CFPI numbers for January 2020 for Rural, Urban and Combined are given in Annexure I. The inflation rates of important categories of items are given in Annexure II. State/UT wise provisional General CPI numbers for Rural, Urban and Combined are given in Annexure III. Inflation rates of major States, having population more than 50 lakhs as per population Census 2011, are given in Annexure IV. State/UT-wise Group CPIs are available on the Ministry's website (www.mospi.gov.in).

4. Price data are collected from selected towns and selected villages by the Field Operations Division of NSO, MoSPI. Price data are received through web portals, maintained by the National Informatics Centre.
