# Introduction and Role of FCI

Food Corporation of India was established under the Food Corporation Act, 1964 , in order to fulfil following objectives of the National Food Policy:-

1. Effective price support operation for safeguarding the interest of producers(Farmers).
2. Distribution of foodgrains throughout the country for Targeted Public Distribution System (TPDS) and Other Welfare Scheme (OWS).
3. Maintaining the satisfactory level of operational and buffer stocks of foodgrains to ensure national food security .



# Introduction and Role of FCI

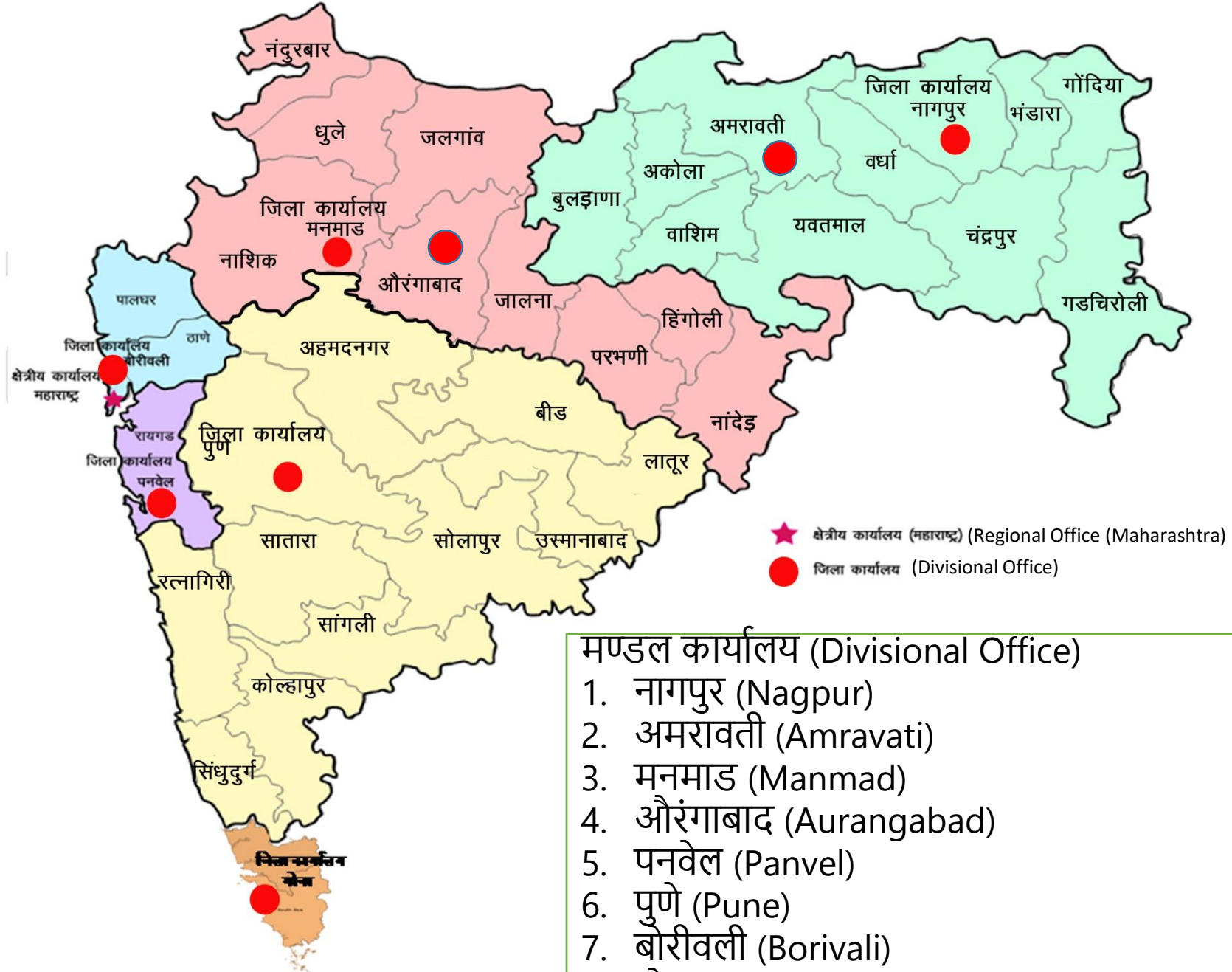
The Food Corporation of India has mandate for the management of procurement , preservation, storage, movement and distribution of foodgrains from food surplus areas to deficit states.

1. The network of FCI has spreaded to far flung areas involving purchase of paddy and wheat at MSP wherever the distress sale is reported thereby backing price stabilisation of foodgrains in the market and economy of the nation as well.
2. The countrywide network of FCI storage depots connected by rail/road ensure continuance of supply chain management in TPDS and other welfare scheme.
3. There is growing quality consciousness among the public/ consumers to meet the expectation in terms of quality standards , purchase are made in accordance with the uniform specifications.
4. The motto of FCI is- **“Better price to farmers and better quality to consumers”**.

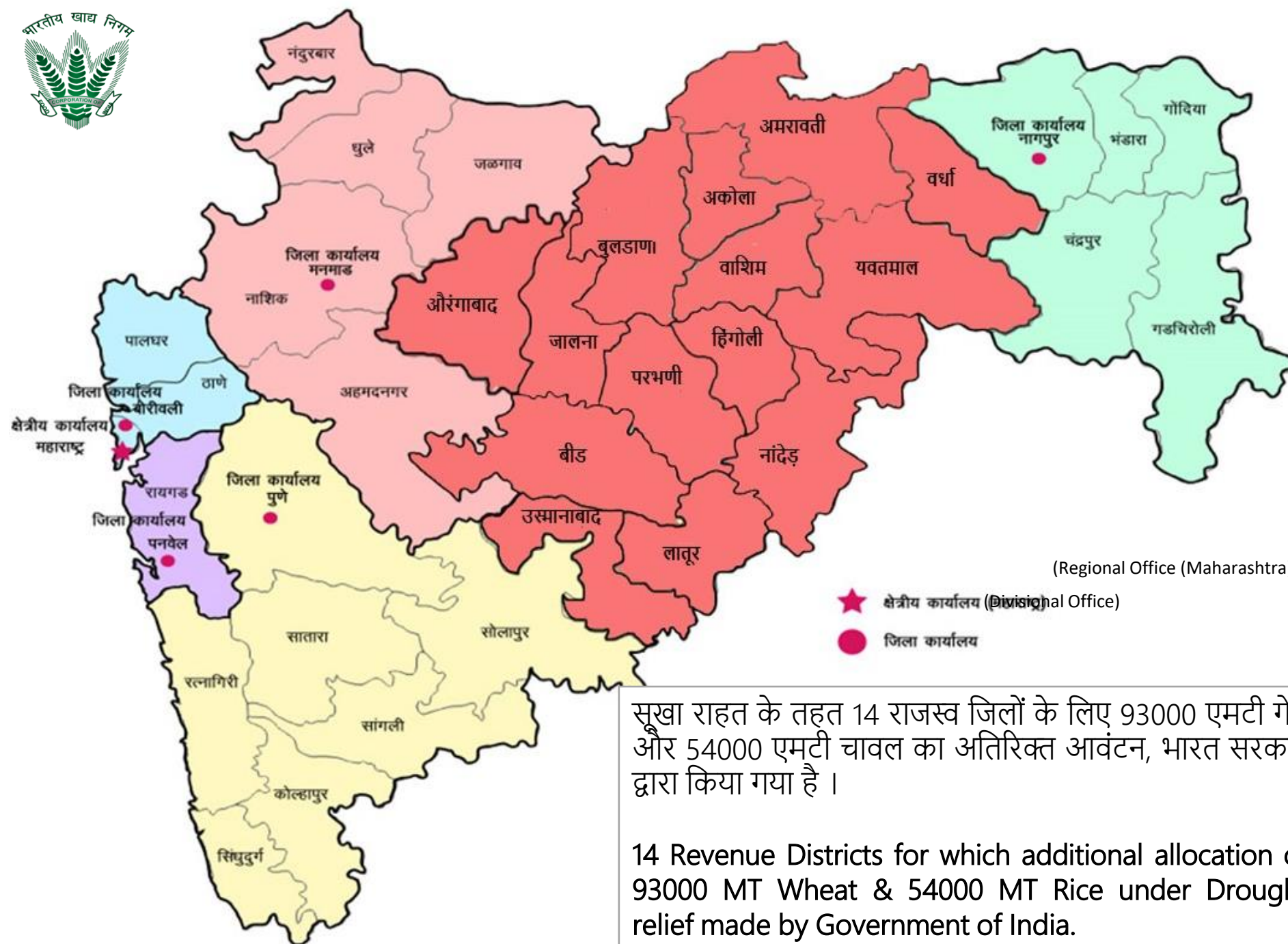

# Pradhan Mantri Garib Kalyan Anna Yojna

- Hon'ble Prime Minister had extended this scheme from July 2021 to November 2021 and accordingly Sufficient Availability of foodgrains had been maintained and as on date the FCI is having 11.02 LMT of Wheat and 6.65 LMT of Rice and further planned for induction of 2 LMT Wheat and 1.5 LMT Rice to ensure surplus availability and storage of foodgrains in all the revenue districts of Maharashtra state.
- **From May 21 onwards, 7 crores NFSA beneficiary had been benefitted in Maharashtra and 5.32 lakhs NFSA beneficiary of Goa had been benefited.**

# Procurement

- **FCI, Maharashtra Region has taken pivotal role in Chana Procurement in last two Rabi seasons by opening procurement centres in remote districts of Maharashtra namely Solapur and Beed and ensured timely payment to the needy farmers within stipulated time period, which had been appreciated by the State Government .**



# PROCUREMENT OF PULSES BY FCI IN MAHARASHTRA

FCI has procured Chana by engaging State Level Supporters in Beed and Solapur revenue districts during RMS 2020-21 and RMS 2021-22 as per GOI instructions. The revenue district-wise procurement of Chana done by FCI in previous years is as follows:

# Action Taken During COVID-19

1. Adoption of Skeletal staff approach, core group, rotation of staff by adopting roster system and control room had been set up in RO level in order to combating the situation of global pandemic.
2. Sanitisation of all office premises, labour sheds by means of Hydrogen peroxide, which is eco-friendly and nontoxic compound which is used for disinfectant for the surfaces, table, chairs, lift and other utensils.
3. Adequate number of sanitizers have been made available in all depots. Also, officials have been assigned the job of sanitization of all persons entering depot. The guard room at entry points had been used for sanitization purpose. Trucks and all vehicle entering in godown are treated with disinfectant.
4. All DO sections, chambers, godown compartment and metallic equipment's like shutters, doors & weighing scales etc are being sanitized with good quality disinfectants, This work is carried out by our own staff. Hydrogen peroxide is used for treatment.



# Action Taken During COVID-19

5. Adherence of all COVID Protocol like social distancing, wearing mask in the office/depot premises and frequent hand washing had been promoted.
6. Wash basins with soap have been fitted at the entrance of each establishment and at prominent places. Also hand sanitizers have been provided at entry points.
7. Thermal scanning facility is also arranged at entrance gate by using ample thermal gun/sensors. Every employee, labours & security guards are allowed to enter into office/depots premise only after duly thermal scanning.
8. Social distancing of 1 Meter is strictly followed by all staff and officers, At the entry gated circles are Marked on the floor to ensure social distancing and all stakeholders entering the depots are following it.

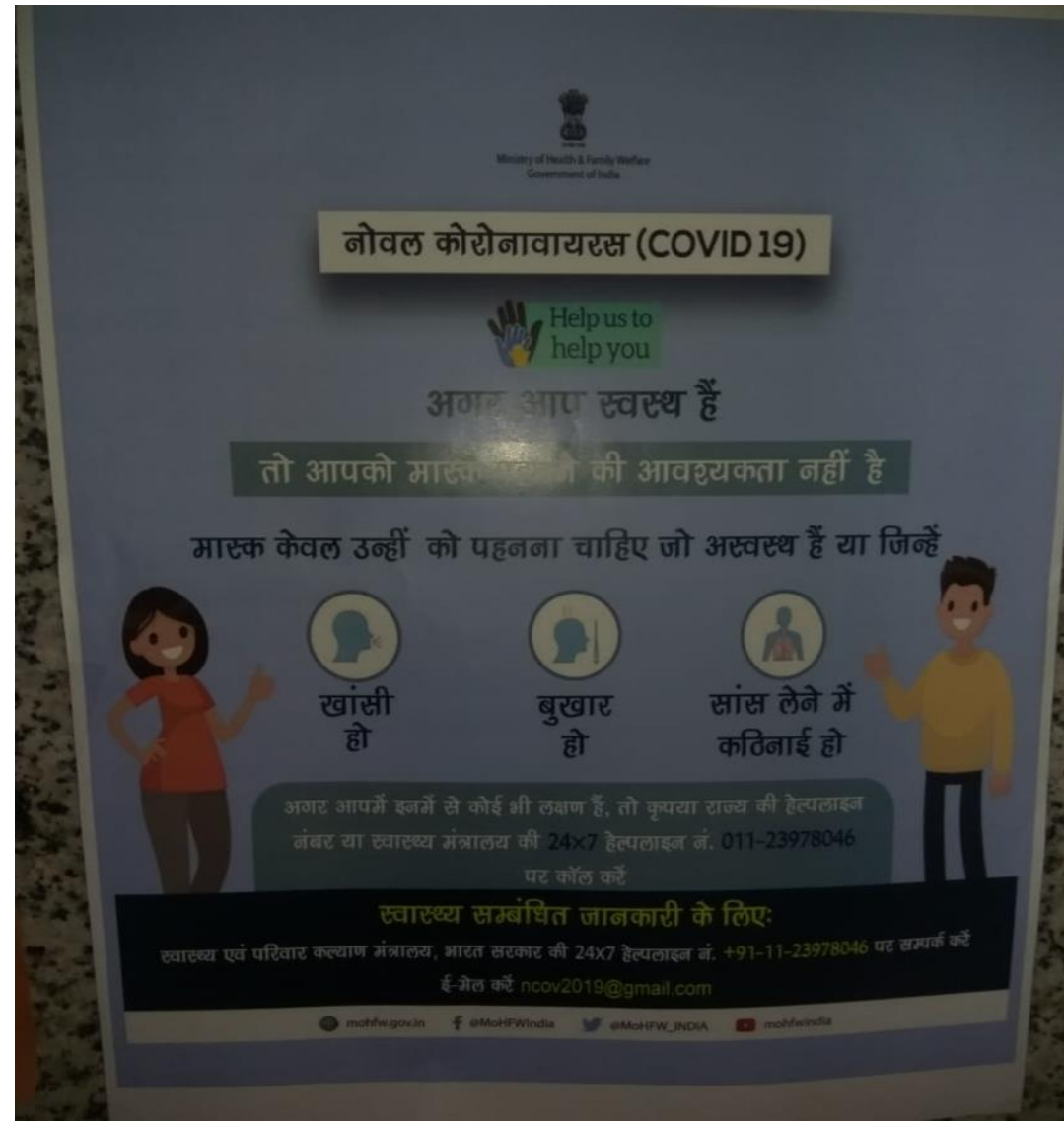
