Dear Shri <Name>

Please accept our greetings for the season and good wishes on personal and business front. We, in the Ministry of MSME, are committed to do all that is required to help businesses re-start. I am particularly writing this to convey our support and solidarity in these difficult times and also to bring out an important issue pertaining to MSMEs.

You are aware that Micro, Small and Medium Enterprises (MSMEs) play an important role in the economy of our Nation. Among other things, they contribute around 30% of the GDP and create employment opportunities for more than 11 crore people. Direct and indirect dependence of households, professionals and workers on MSME sector is all-pervasive. Many of the MSMEs must be doing business with your esteemed group, the companies and entities thereof.

In recent months, particularly as a result of Covid-19, there is visible stress in the business of all entities, but more so in the MSME sector. One of the problems is that the payments due to the MSMEs are not coming from buyers and users of their goods and services. The situation had become so acute that the issue formed part of the announcements made under the AtmaNirbhar Bharat package by Hon'ble Finance Minister on 13th May, 2020. By way of this announcement, it was directed that the MSME receivables must be paid within 45 days.

As a follow up to the announcements under AtmaNirbhar Bharat package, our Ministry, with support of other Ministries & Departments, has tried for getting such delayed payments released. This has led to payment of substantial amounts from public and private sector companies as well as Central and State Government agencies. I take this opportunity to thank all those who have responded to the call of the Government and made the due payments to MSMEs.

However, still, a lot remains pending; a lot remains to be done. In this regard, I have to make three specific suggestions and requests:

- You will agree that such payments are very important for MSME operations and sustenance of jobs and other economic activities at the
 grass-root level. This will ultimately benefit the entire economy including your own operations. Therefore, I request you to kindly
 examine whether any such payments are pending at your end and release the same at the earliest;
- Towards a solution of the issue of cash flows of MSMEs, it was made mandatory by the Ministry of MSME on November 02, 2018, for all CPSEs and corporate entities with more than Rs. 500 Crore turnover to onboard themselves on the TReDS platforms. Many corporates are yet to join or transact. You are requested to onboard your company on the TReDS and start transacting;
- Also, Government of India has made it mandatory for all the corporate entities to file half-yearly returns with the MCA on their dues to
 MSMEs. This, too, is not being followed by many of the corporate entities. I would request your company to file returns if not doing so
 already.

You may be aware that payment of MSME receivables within 45 days is mandated under the MSME Development Act, 2006, which is administered by this Ministry. Moreover, your gesture will be a timely contribution for the economy of the Nation. It will help bringing smile on millions of faces whose only source of livelihood are these smaller units.

Kindly accept the greetings from MSME family for the coming festive season including Diwali. We wish you, your family and workers a healthy, happy and heartening time ahead.

Some of you may recall that I had written last month to sensitize about the pending payments of MSMEs. I feel happy to convey that very good response has been seen from the Corporate India towards the smaller, ancillary and supplier units. If we consider the period of last five months, maximum payment to MSMEs appears to have happened in the month of September, 2020. Not only that, in that timeframe, even the procurements and transactions appear to be maximum in the month of September. I am saying this on the basis of inputs from the Central Public Sector Enterprises (CPSEs). More than Rs. 13400 crores have been paid by CPSEs to MSMEs in the last five months. Out of this, payments worth Rs. 3700 crores have happened in September alone. I take this opportunity to convey our sincere thanks to the corporate sector of the country for this gesture. We have made relentless efforts including personal follow-up and digital intervention for this purpose. In that direction, encouraged with the above outcome, I am addressing to an even wider corporate community of the Nation.

As you know, MSMEs are the backbone of our economy and directly affect the livelihood of a large section of our society. Along with you, they have seen the worst of the business cycles in the last few months. However, since their capacity to withstand is small, they are facingmore distress and need to be supported. Also, if their cash flows improve, they can make use of the coming festival season when there is opportunity to earn by supplying goods and services. In fact, some of them look for such a period for their sustenance of the whole year. Thus, timely payment of their receivables will not only support the MSMEs and their dependents in this festive season but will also sustain many of them for full year. Therefore, I sincerely request you to kindly see if any such dues are pending. If so, please arrange for payment as soon as possible, preferably in this month itself.

In addition, I would also like to remind you that:

- It is ideal that payments are made in stipulated time. However, in absence of that, to solve the cash flow problems of MSMEs, a
 bill discounting mechanism has been started by the RBI in the name of TReDS. It is mandatory for all CPSEs and other
 companies with turnover of more than Rs. 500 Crore to join this platform. However, many companies are yet to join it or
 transact thereon. You are requested to check whether your group/company has joined the TReDS platform and is doing
 transactions:
- The MSME Development Act, 2006 mandates to make such payments within 45 days. As per related Government instructions, the corporate entities are supposed to file half-yearly returns with the Ministry of Corporate Affairs about the dues of MSMEs. In many cases, this too is not being done. I request for your attention and needful action on this also.

Government is very keen to see that payment of receivables to MSMEs is made on time. Considering its importance, a very categorical appeal was made in the Atma Nirbhar Bharat Package. Hence, I request you to do your utmost on this issue. Your small gesture during this period can go a long way and brighten lakhs of homes and crores of faces.



We consider our suppliers as our partners, who are important not just to keep the business moving but also ensure our products meet the customer expectations in the challenging Indian market. Strong and robust _____Supplier partnership is one of the priority areas for us.

About 400+ supplier partners currently supply goods and services to us across the length and breadth of the nation and 15% of our supply base falls under the Micro/Small supplier category. As per MSME guidelines, we are committed to making payments to these suppliers within 45 days. Returns are being filed half yearly, wherever applicable with Ministry of Corporate Affairs.

For supporting cash flow concerns of our Supplier Partners, we have introduced Supplier Financing Program. Under this program, our bankers pay the trade receivables of our supplier partners within 7 days of processing the invoice. We have initiated the necessary steps for registering with TREDS and the process is expected to be completed soon.

- We have ensured all our MSME vendors have term of payment 45 days or less and ensure payment of the dues to them on time. I am happy to state that we ensured zero dues to MSMEs as on 30th September 2020 over 45 days.
- 3. As per the MCA notification we have already registered with TReDS platform
- We have also filed the half yearly returns that is required to be filed on time wherever there is an outstanding due to MSME vendors more than 45 days.
